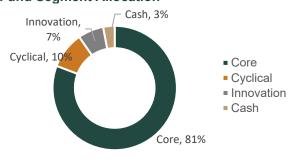

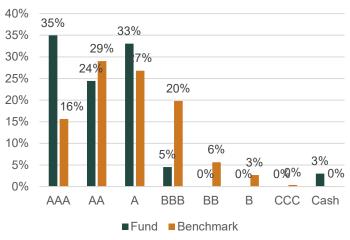

Fund Segment Allocation



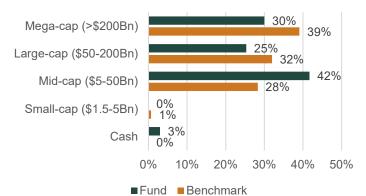
